The CEFA training program

Objectives & target group

The CEFA evaluates the set of banking and financial skills necessary to carry out financial analysis, advisory and investment as well as portfolio management tasks.

Our training program is focused on the **professional background of analysts, portfolio managers, fund managers, CFOs, asset managers and all other financial professionals**. A multitude of financial organizations enrol their employees in this professional and interactive program.

Ensuring that investment professionals receive the best possible training has always been a top priority at ABAF/BVFA. Accreditation

EFFAS, the European Federation of Financial Analyst Societies, has accredited the CEFA designation internationally. In Belgium, the courses are organised by its Belgian representative, i.e. ABAF/BVFA. **Successful students obtain the international EFFAS CEFA accreditation**, equivalent to a master's degree and pitched to level 7 of the European Qualifications Framework (EQF).

The CEFA Quality is controlled by the EFFAS Review Panel, an independent high-level academic body. Our diploma **respects local market requirements, conditions and characteristics as well as individual cultures**. That's why the CEFA diploma designation is recognized in the Eurozone as well as by the FCA in UK, the Regulator of Financial Services in Malta and their counterparts in Greece, Portugal, Brazil, Romania, Spain and Argentina.

Program outline

The complete CEFA program consists of **91 hours classroom training (physical or Teams)**, split over 11 different modules, and a significant part of self-study per module.

Students can also follow this training per block or per module.

The first block, “**Financial Landscape**” teaches you all principles needed to operate as a finance professional in general.

The second block, “**Main Product Lines**” provides you with the profound knowledge of portfolio products, the building blocks of Equity, Corporate Finance and Debt products.

The third block are the “**Advanced Topics**” such as portfolio management, the use of derivatives, structured products and ESG.

Prof. Hans Buysse

Hans Buysse is chairman of ABAF/BVFA since 2019 and represents the association internationally. He was vice-chairman of the organization from 2013 to 2019 and chairman from 2004 to 2013. He is EFFAS Executive Management Committee member and EFRAG Administrative Board President. He has been member of the Consultative Working Group (CWG) of the Corporate Reporting Standard Committee (CRSC) of ESMA. Hans Buysse is managing partner at Clairfield International and adjunct professor at Vlerick Business School.



Prof. Serge Pattyn

Serge Pattyn is a former sell-side analyst and operates now as an independent financial analyst and corporate finance advisor. He is vice-chairman of the EFRAG Financial Reporting Board and former member of EFRAG's Technical Expert Group (TEG) in which he represented the users from 2012-2018. He is still a member of EFRAG's User Panel and EFFAS' Commission on Financial Reporting, two bodies that provide the analyst views on financial and corporate reporting. He is a much sought-after guest lecturer on Financial Accounting and Financial Statements Analysis, IFRS and valuation. Serge Pattyn is a board member at ABAF/BVFA.



Prof. Jan Longeval

Jan Longeval has a career in asset management that spans 30 years. He worked at Bank Degroef where he became CEO of Degroef Securities. He later became head of institutional asset management and joined the group executive committee and the board of directors of Bank Degroef. He left the bank in 2017 and set up Kounselor Consulting bv. Prof. Dr. Cynthia Van Hulle

Cynthia Van Hulle is professor at the Faculty of Economics and Business of KU Leuven. She was a visiting professor at Columbia Graduate Business School and at the graduate business school of the university of Chicago (USA). During the 2009-2010 academic year, she held the Francqui Chair at the University of Ghent. Cynthia Van Hulle holds a PhD in applied economics from KU Leuven. She is board member of WDP, Argenta and ArgenCo and an independent director at Miko Group.

Luc Keuleneer is professor in finance at different universities in Belgium and the Netherlands. He is/was also member of the Supervisory Board and the Audit Committee in different companies (Euronext, SFPI-FPIM, Wealthon, ...). Luc Keuleneer is Secretary General of ABAF/BVFA.



Prof. Kris Devos

Kris Devos has built up a considerable experience across a range of capital markets activities in sales, trading and syndicate area. Kris is head of the Investment Grade Syndicate where he has worked on all major transactions ING lead-managed in the Corporates, Financials and SSA. Kris Devos is global head of ING's Debt Syndicate desk and appointed to head of CEE/CIS/ Asia origination. Today, Kris oversees all global debt syndicate operations both in the public and private markets for all ING's corporate, financial and agency clients.



Prof. Wim Van Hyfte, PhD

Wim Van Hyfte is Global Head of ESG Investments and Research at Candriam since 2016. He is responsible for research on ESG issues, the implications for and the integration into portfolio and risk management across asset classes. He joined Candriam in 2006 after having worked in the academic world for over 8 years.

Since 2018, he teaches Sustainable Finance at Vlerick Business School. From 2012 to 2020, he was Visiting Professor at ULB Solvay School of Economics and Management teaching Asset Pricing in the Advanced Master in Quantitative Finance. From 2006 until 2012, he was Visiting Professor at Vlerick Business School teaching on portfolio management in an MBA program.



Prof. Steven Trypsteen

Steven Trypsteen is a Financial Risk Specialist within the Credit Portfolio Management team at ING Belgium. He monitors the credit portfolios, conducts analyses in order to better understand various risks and proposes mitigating measures if needed. Steven is also a visiting lecturer at the University of Antwerp, where he teaches macroeconomics, and a lecturer at Febelfin, where he teaches a module on the housing market.

Examinations

The program is composed of 11 separate modules and as such of 11 examinations. Those examinations are mostly based on a multiple-choice questions. Examinations are corrected within two weeks following the examination dates and participants will be informed whether they pass or not.

Students receive all course material (manuals, lecturer's presentations, examples of previous exams,...) in advance in order to prepare for the exams.

Exams are organized in class (physical presence needed). For students following the complete program, examinations are organized per block and thus, all modules of a single block will be examined the same day. Following the EFFAS rules of conduct, students aren't allowed to split the exams of the first session over the two days. Students will be able to retake the exam(s) for which they didn't pass during the first examination session. The re-sitting is organized about 3 weeks after the first examination.

Examinations will take place on the dates mentioned in the table below. The first date is the first session during which all modules of a block are examined. The second date refers to the re-sitting of the exams for which a student didn't pass.

Practical information

Dates and location

- As we highly value interactive teachings, we offer this course via a blended training program with both online and physical classes.
- Classroom teachings and exams from February until December 2023: 9h - 12h30 and 13h30 - 17h, 7 hours per session.
- Location: the classroom teachings will take place in Brussels or Antwerp. Depending on the number of registrations, classroom teachings can be replaced by online classes.
 - 91 hours classroom teachings (physically/Teams) + a significant part of self-study
 - complete program split over 11 modules, but registration per block/module is possible
 - approx. 5 hours examination per block.

Admission conditions

Candidates must hold a master degree or have 3 years of experience in a relevant field to the financial profession. Exceptions, at the discretion of the organizational committee, can be made for candidates with non-master degrees but with appropriate experience. All classes are conducted in English.



Registration fees

We advise to follow the program completely or per block of 4-5 modules. When you subscribe for the complete program you will benefit from a reduction. You can also choose to spread the program over 3 years. Finally, you can also subscribe per module. We reserve our right to spread the program over more than one year if the minimal required number of students has not been attained.

After evaluation of your subscription, we will inform you about your admission to the CEFA program by mail. For the full program, the registration and payment have to be done before 13 January 2023. When you subscribe for a particular module, the registration has to be done 30 days before the start of the module.
